### As per the LCHCT By-Laws, Classes of Membership:

**\$20 Youth-one person less than 18 years of age that is sponsored by an active member. Any youth sponsored by a member must have a notarized wavier and medical release form signed by parent upon joining.**

**\$20 Single-one person 18 years of age or older.**

**\$30 Family-two adult persons and all children under 18 years of age residing at that residence.**

**\$50 Business-any entity recognized by the state of Florida.**

**\$10 Affiliate-non-voting. Must be a member in good standing of another recognized equestrian organization.**

**\$0 Honorary-as voted on by the membership.**

\*LCHCT membership begins March 1<sup>st</sup> of each year and expires the last day of February the following year. New members joining each month after March will have their dues prorated thru the last day of February with full renewal due by March 1<sup>st</sup>. Prorated amounts are \$1.67 per month for \$20 memberships, and \$2.50 per month for \$30 memberships. i.e.; \$30 family member joins in the first half of October with five months left before March 1<sup>st</sup> would pay 5 x \$2.50 = \$12.50 (paying for Oct-February).

**Qualifications of membership: People who agree to fulfill the objectives of Article II and abide by the By-Laws.**
